## TERMS AND CONDITIONS TO MEMBERSHIP AGREEMENT

*Please read and sign below*

**1. Membership Terms.** Summer Membership begins Memorial Day weekend and ends on Labor Day. This Membership Agreement is for the entire duration of the GJCC summer season. The membership will expire after the Labor Day holiday. Summer members will receive notice if the summer season extends past Labor Day, in which case summer members may continue to use the outdoor pool facility. During the GJCC summer season, this membership MAY NOT BE CANCELLED. Summer members will *not* receive a refund of dues for lack of use of the Center during any portion of the summer. Member is responsible for payment of all dues and charges for the entire length of this Membership Agreement.

**2. Member rates do not apply to Camp Davis and Early Childhood Learning Center.**

**3. Rules.** Member agrees to abide by the policies, rules, and regulations of the Center and to behave with appropriate conduct which would include but is not limited to damage or destruction of JCC property, theft, follow proper safety precautions and practices, appropriate behavior, no fighting, no harassment (including physical and verbal abuse) of other participants and staff and understands that rules may be changed from time to time.

**4. Physical Condition/No Medical Advice.** All Members individually represent that he/she has no known medical condition or impairment that might prevent Member from his/her intended use of the GJCC's facilities and services. Member acknowledges that GJCC did not provide Member with any medical advice at any time relating to Member's physical condition and Member's ability to use the GJCC's facilities and services. If Member has any medical concerns, those concerns should be discussed with Member's personal physician before Member uses GJCC's facilities and services.

**5. Incidentals.** The GJCC reserves the right to charge fees for: lockers, guests, childcare, swim lessons, personal training, special activities, changes in membership status, returned checks, late fees, etc. The GJCC may change fees at any time.

**5. Delinquent Accounts.** Accounts delinquent over 60 days may be referred to a collection agency or to an attorney. Member agrees to pay reasonable attorneys' and collection fees and costs, in addition to damages, incurred by the GJCC in any action to collect unpaid dues or charges. The GJCC may terminate memberships for non-payment of any sums due by member.

**7. Expulsion of Member.** The GJCC reserves the right to terminate any Member's membership for the following reasons:

1) A violation of any of the GJCC rules, or 2) Conduct which in the sole discretion of the GJCC's management is detrimental to the welfare, health and safety of the GJCC's Members or staff or the GJCC's reputation, goodwill or character. In the event of such termination, Member's liability for future monthly dues shall cease. Member shall remain liable for all unpaid dues and charges incurred prior to the time of termination.

**8 Membership Key Card and Fob.** Member will present key card and key fob each time the Center is used. Member agrees to pay a replacement fee of \$10 for a lost or stolen fob, and \$5 for a lost or stolen key card. Member will return key fob to the GJCC after the summer season or will be charged \$10.

**9. Video Surveillance.** The GJCC reserves the right to conduct video surveillance of all interior and exterior areas of the GJCC's premises.

**10. Use of Likeness.** The GJCC reserves the right to photograph and/or videotape activities for use in publicity and promotional materials. Please notify the GJCC in writing if you do not want photos of yourself or your family members to be used.

**11. Assignment.** This Agreement may be assigned by the GJCC in its sole and absolute discretion. Members may not assign any rights they have under this Agreement.
