

WAIVER, RELEASE, AND INDEMNIFICATION AGREEMENT

Please read and sign below

In consideration for being permitted to utilize the facilities, services, and programs of the Gordon Jewish Community Center (GJCC) for any purpose, including but not limited to observation or use of facilities or equipment, or participation in any program affiliated with the GJCC, without respect to location, the undersigned, for himself or herself and any personal representatives, heirs, and next of kin, hereby acknowledges, agrees and represents that he or she has, or immediately upon entering or participating will inspect and carefully consider such premises and facilities or the affiliated program. It is further warranted that such entry into the GJCC for observation or use of any facilities or equipment or participation in such affiliated program constitutes an acknowledgement that such premises and all facilities and equipment thereon and such affiliated programs have reasonably suited for the purpose of such observation, use, or participation.

LIMITED TO OBSERVATION OR USE OF FACILITIES OR EQUIPMENT, OR PARTICIPATION IN ANY PROGRAM AFFILIATED WITH THE GJCC, WITHOUT RESPECT TO LOCATION, THE UNDERSIGNED HEREBY AGREES TO THE FOLLOWING:

1. THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the GJCC, its directors, officers, employees, and agents (hereinafter referred to as "releasees") from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releasees or otherwise while the undersigned affiliated with the GJCC, without respect to location.
2. THE UNDERSIGNED HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releasees and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in, upon, or about the GJCC premises or in any way observing or using any facilities or equipment of the GJCC or participating in any program affiliated with the GJCC whether caused by the negligence of the releasees or otherwise.
3. THE UNDERSIGNED HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE due to negligence of releasees or otherwise while in, about, or upon the premises of the GJCC and/or while using the premises or any facilities or equipment thereon or participating in any program affiliated with the GJCC.

THE UNDERSIGNED further expressly agrees that the foregoing RELEASE, WAIVER AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as is permitted by the law of the state of Tennessee and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

TERMS AND CONDITIONS TO MEMBERSHIP AGREEMENT

Please read and sign below

- Membership Renewal/Cancellation.** This Membership Agreement is a continuous membership plan, with a minimum commitment of 12 months. After the initial membership period has expired, this Membership Agreement will automatically renew on a month-to-month basis on the terms and conditions stated in this Agreement. Special Note: During initial 12-month period, membership MAY NOT BE CANCELLED prior to the end of the initial membership period except in circumstances of moving/relocation of greater than 50 miles or medical conditions which preclude the member from physically using the facilities and the condition is verified by a physician. Members wishing to cancel their Membership, regardless of length of term, must submit such request in writing at least thirty (30) days prior to the expiration of the term in the Membership Agreement. Member is responsible for payment of all dues and charges for the entire length of this Membership Agreement.
- Rules.** Member agrees to abide by the policies, rules, and regulations of the Center and to behave with appropriate conduct which would include but is not limited to damage or destruction of JCC property, theft, follow proper safety precautions and practices, appropriate behavior, no fighting, no harassment (including physical and verbal abuse) of other participants and staff and understands that rules may be changed from time to time.
- Membership Enrollment and Monthly Dues.** Membership enrollment fee is a one-time fee provided that the membership status does not change or lapse. Members rejoining greater than 90 days after cancelling are required to pay enrollment fee. ENROLLMENT FEES ARE NON-REFUNDABLE. The GJCC reserves the right to increase dues no more than once per 12-month period with no less than 30-day advance written notice to the Member. Membership fees are non-refundable, non-transferrable, and no refunds are granted for non-use of the facility.
- Summer Membership:** Terminated members are not eligible for a summer membership the year in which they terminate annual membership.
- Physical Condition/No Medical Advice.** All Members individually represent that he/she has no known medical condition or impairment that might prevent Member from his/her intended use of the GJCC's facilities and services. Member acknowledges that GJCC did not provide Member with any medical advice at any time relating to Member's physical condition and Member's ability to use the GJCC's facilities and services. If Member has any medical concerns, those concerns should be discussed with Member's personal physician before Member uses GJCC's facilities and services.
- Holds.** Memberships may be temporarily placed on hold for up to six (6) months due to medical reasons or travel plans. Written requests for placing your membership on hold must be sent and acknowledged by the Membership Department prior to the beginning of the month that you would like your hold to begin. Memberships for those who pay annually will be extended by the duration of the hold.
- Incidentals.** The GJCC reserves the right to charge fees for: lockers, guests, childcare, swim lessons, personal training, special activities, changes in membership status, returned checks, late fees, etc. The GJCC may change fees at any time.
- Change of Address.** Members shall give written notice to the GJCC of changes in address or other contact information.
- Delinquent Accounts.** Accounts delinquent over 60 days may be referred to a collection agency or to an attorney. Member agrees to pay reasonable attorneys' and collection fees and costs, in addition to damages, incurred by the GJCC in any action to collect unpaid dues or charges. The GJCC may terminate memberships for non-payment of any sums due by member.
- Changes in Membership Status.** If a Member desires to change the status of his or her membership, the Member shall forward written notice of the request to the GJCC setting forth the desired change.
- Expulsion of Member.** The GJCC reserves the right to terminate any Member's membership for the following reasons:
 1) A violation of any of the GJCC rules, or 2) Conduct which in the sole discretion of the GJCC's management is detrimental to the welfare, health and safety of the GJCC's Members or staff or the GJCC's reputation, goodwill or character. In the event of such termination, Member's liability for future monthly dues shall cease. Member shall remain liable for all unpaid dues and charges incurred prior to the time of termination.
- Membership Key Card and Fob.** I will present my key card and key fob each time I use the Center. I agree to pay a replacement fee of \$10 for a lost or stolen fob.
- Video Surveillance.** The GJCC reserves the right to conduct video surveillance of all interior and exterior areas of the GJCC's premises.
- Use of Likeness.** The GJCC reserves the right to photograph and/or videotape activities for use in publicity and promotional materials. Please notify the GJCC in writing if you do not want photos of yourself or your family members to be used.
- Assignment.** This Agreement may be assigned by the GJCC in its sole and absolute discretion. Members may not assign any rights they have under this Agreement.
